Spring Valley Manor Property Owners Association Special Meeting - November 16, 2017

Location: Korean Church; 600 Kirby Road; Little Rock, AR

Time: 6:30pm

Re: Amending of SVM's Articles of Incorporation

Thirty-one Spring Valley Manor residents attended the meeting plus a guest of Medine Watson. Board members present: Jena McDonnell, David Pru'domme, Stacy Harter, Brian Sirak, Erin Tripcony, Tim Hose, Anita Spence.

At 6:30pm, Jena McDonnell, POA President, did introductions and general announcements.

Robert Coleman asked to speak and was given the floor. Robert Coleman stated he had conferenced with 3 attorneys regarding the need for the Property Owners Association to carry liability insurance. He stated all 3 attorneys had said non-profit organizations are not allowed to be sued and therefore there is no need for the POA to carry liability insurance. Cindy Aberding is an attorney who works for a non-profit and said she did not believe this is true. Research will be done to determine validity of Coleman's statement. Coleman also voiced his opinion that he disagreed with SVM's Rules of Conduct and Safety, in that there should be no age restrictions for children to be allowed to swim unsupervised by an adult. He was asked to table his thoughts on this matter until the meeting that would be scheduled specifically to go over the new Rules of Conduct and Safety.

Brian Shirak did a brief talk explaining the reasoning behind the Board's decision to update all of the Association's documents. Next, Jena McDonnell gave a report pertaining to the litigation the POA has been involved in since June with one of the SVM members (summary attached).

Meeting was called to order at 7:05pm.

Brian Sirak briefly explained what the Articles of Incorporation were, why they needed to be updated, and how tonight's amendment process would work.

Article I - No amendment was proposed for this Article.

Article II - No amendment was proposed for this Article.

Article III - No amendment was proposed for this Article.

Article IV - The Board proposed the following amendments to Article IV:

- 1. Resubmit Exhibit B (Plat A, B, C, D, E and F) since it has been lost by the City of Little Rock
- 2. Change sentence 2, "There shall be as many memberships as there are lot and tract ownerships in Plat A, B, C, D, E and F of the said Spring Valley Manor Subdivision platted on and out of the area described in Exhibit B hereto consisting of 127 lots." **PROPOSED**: "There shall be as many memberships as there are lot and tract ownerships in Plat A, B, C, D, E and F of the said Spring Valley Manor Subdivision platted on and out of the area hereto described in Exhibit B. The official number of lots to be the same as reflected in Spring Valley Manor's Suburban Improvement District #7's Tax Bill."

Motion was made to accept both proposed amendments. Motion was seconded. Motion passed with none in opposition.

<u>Article V</u> - Article V was amended on June 29, 1978. Board proposed Article V remain the same as 1978 amended version (attached). Motion was made to ratify the 1978 amendment. Motion was seconded. Motion passed with none in opposition. Article V will remain the same as amended in 1978.

A short discussion ensured regarding continuity of voting specifics between Association documents. Ross Phillips made motion for Board to review, align and amend Association documents, including voting specifics between documents. Also, By-Laws and Articles of Incorporation to be amended to reflect, "A quorum at any meeting shall be those members present and qualified to vote, as well as By-Laws and Articles of Incorporation cannot be changed without two-thirds "yes" vote of members present and voting;" and mention needs to be made regarding mandatory dues specifics. Motion was seconded. Motion passed with none in opposition.

Article VI - The Board proposed the following amendment to Article VI:

1. Add the following sentence, "A SVM POA Member must have served on the POA Board a minimum of one year before they are eligible to serve on the Executive Board (President, Vice-President, Secretary, Treasurer).

A brief discussion followed with Jake Brandt making an additional amendment proposal to Article VI:

2. Change the last sentence, "A vacancy on the board may be filled by appointment of the remaining directors from the remaining members of the corporation, and such appointee shall serve the remainder of the term for which he was appointed." **PROPOSED**: "A vacancy on the board may be filled by appointment of the remaining directors from the remaining members of the corporation, and such appointee shall serve until the next legally constituted election."

Motion was made to accept both proposed amendments. Motion was seconded. Motion passed with none in opposition.

<u>Article VII</u> - A brief discussion regarding the third sentence of Article VII, "The Board may create as many assistant offices as the business of the corporation shall require and shall appoint as assistant officers persons who are members of the corporation." There was a concern that this left the door open for the Board to "stack" the Board officers in a manner that would be beneficial to the Board and not to the membership at large. A proposal was made to delete this sentence from Articles VII. Short discussion to also include information regarding mandatory dues followed.

Motion was made to accept proposed amendment to delete sentence 3 from Article VII and incorporate mandatory dues information. Motion was seconded. Motion passed with none in opposition.

<u>Article VIII -</u> Prior to tonight's meeting, the Board sent an email out to the membership at large. In the email it stated they would be proposing the following amendment to Article VIII, "Any proposed amendments to the By-Laws must be sent to the membership at large for their review a minimum of five business days before calling for a vote of said proposed amendments." Robert Arnold email Stacy Harter prior to this meeting and requested changing the 5 day minimum to 15-30 days. Discussion followed with the following made made, "Any proposed amendments to the Articles of Incorporation or By-Laws must be sent to the membership at large for their review a minimum of 15 and maximum of 30 days before calling for a vote of said proposed amendments."

Motion was made to accept proposed amendment. Motion was seconded. Motion passed with none in opposition.

Article IX - The Board proposed to change the registered office of the corporation from 1805 Union National Plaza to Fulton Park's official mailing address. They also proposed to change the registered agent of the corporation from Paul A. Schmidt to the Spring Valley Manor Property Owner's Association. Mail can be forwarded to Board President if allowed by law.

- 1. The initial registered office of the corporation shall be 16501 Cooper Orbit Road, Little Rock, Arkansas 72210. Mail be forwarded to President's home address if allowed by law.
- 2. The initial registered agent of the corporation is Spring Valley Manor Property Owner's Association.

Motion was made to accept both proposed amendments. Motion was seconded. Motion passed with none in opposition.

Article X - No amendment was proposed for this Article.

Article XI - No amendment was proposed for this Article.

Article XII - No amendment was proposed for this Article.

No further discussion or motions. Motion was made to adjourn the meeting. Motion was seconded. Motion passed with none in opposition.

Meeting adjourned at 7:45pm.

ARTICLES OF INCORPORATION

OF

SPRING VALLEY MANOR PROEPRTY OWERNS ASSOCIATION, INC.

AMENDMENT

ARTICLE V

The members shall meet at least once annually upon written notice given each member not less than ten days nor more than 20 days before the date of such meeting. Special meetings may be called at any time by the board of directors upon the same notice; and special meetings shall be called upon the written request for a special meeting of 15% of the number of members. Such written request and all notices of special meetings shall state the purpose or purposes for which the special meeting is called, and only such stated purpose or purposes shall be considered at such special meeting. A quorum at any meeting shall be those members present and qualified to vote. By-Laws and Articles of Incorporation cannot be changed without two-thirds "yes" vote of members present and voting at membership meeting or called special meeting. Each membership entitles the holder to one vote at meetings, and a member may vote by, and be counted in respect of, a proxy or proxies. Meetings shall be conducted according to the then-current edition of Roberts Rules of Order; and except where otherwise provided in these Articles or in the By-Laws, a majority of those memberships present and voting shall decide all questions put to a vote.

Spring Valley Manor Property Owners Association Current SVM Announcement Re: Ongoing SVM Member Litigation Battle with Board

SVM is using Attorney Rusty Sparks for not only for this summer's SVM Resident violation and ongoing SVM Resident legal guidance, but also for legal advice regarding updating of Association documents.

Issue #1 - Reported Violation - Resolved

- Contact w/ property owner made by Board President, Jena McDonnell, in an attempt to resolve violation amicably. Jena's attempt was meet with residence and Jena reported non-cooperation to the Board.
- Board delivered written notice of violation to residents
- Residents responded they were seeking legal counsel and at that point the Board was obligated to also retain counsel for legal advice.
- Attorneys exchanged correspondence for 4+ months until matter resolved with SVM resident found in violation.

Issue #2 - Requested Association Documents - Ongoing

Within a few weeks of Issue #1 being resolved, SVM resident contacted the Board with more questions and requests for administrative and operational documentation of SVM POA. Due to the fact that some of the SVM Resident's inquiries were non-SVM specific, the Board felt prudent to continue seeking advice of counsel in order to fulfill obligation to Association members.

The Board has a legal obligation to deal with each and every member's cares and concerns in a diligent and respectful manner. There will always be challenges to the Rules, many of which can be resolved internally, some unfortunately cannot be. The Board is attempting to resolve this as amicably as possible and will continue to do so.

Legal fees the Association as a whole is obligated to pay to date pertaining to dealing with the SVM resident's violation and continued demands is close to \$2,000. Until this specific SVM resident chooses to stop challenging the Board and Association as a whole, the Board has no choice but to continue to address his requests in a prudent manner.
