SVM POA Neighborhood Contacts – Talking Points

 - If interest expressed feel free to provide list of current board members
- Several important information items to pass on:
 - 31Mar11 Thursday - SID (Suburban Improvement District) Commissioner nomination meeting at the Korean Disciple Church at 7:00 PM (600 Kirby Road); followed by the all neighborhood POA meeting
 - Spring Neighborhood Clean-up 09April 11 (Saturday) - gather at beach at 09:30 AM to form clean-up teams
 - Two dumpsters have been arranged this year to be delivered on Thursday or Friday (one placed below dam on Vista and one at 14918 Gorgeous View Trail)
 - There is the usual restricted/prohibited items list that will be distributed at the meeting and by email
 - Anyone especially interested in helping with the clean-up of the front yard areas of the vacant property at 14918 Gorgeous View Trail is asked to contact Jon Ford (225-2901)
- Discuss need for neighborhood directory update
 - Confirm/update prior directory info (we will be completing a spreadsheet for our assigned contacts to provide back to John for consolidation)
 - Provide additional info for board use/reference as appropriate (e.g., owner vs. lessee and info for both, property currently for sale, vacant, etc.)
- Discuss neighborhood website and elicit input
 - Explain current POA Board desire to improving neighborhood communication and the dissemination of information easily and swiftly, by creating a private SVM user group and Website using free Google services
 - Access limited to user group members only (requires invitation from SMV POA user group master)
 - To join the SVMPOA Google user group will require signing up for a Google user ID if you don't already have one (free, and does not require use of a Google email address). User directions would be provided with the invitation to join.
 - Website would include an event calendar, announcements, neighborhood classifieds, the neighborhood directory, helpful links, and other sections as found useful or desired
 - Elicit Input:
 - Do you current have Internet access?
 - Is this a desirable way for you to receive information regarding SVM neighborhood, and to communicate with POA & SID Boards and your other neighbors?
 - Do you have any suggestions, comments, or concerns regarding the use of a neighborhood only Website/User Group?
 - Important to note if this neighbor needs non-electronic contact, and to convey to them that we are working on a list of these individuals simultaneously so that we know how best to keep them updated with the same information via other means (e.g., phone calls, printed materials)
