Meeting called to order by POA President at 7:00pm. Welcome/introductions made with 27 POA members in attendance (attach #1).

OLD BUSINESS

2019 Annual POA Meeting Minutes & Financial Report reviewed and approved with none in opposition (attach #2 & #3).

Chicken Issue: POA President presented a brief recap of the ongoing "chicken issue" followed by a short discussion. Multiple attempts made to contact member in violation with no response. 2020 POA Financial Report: POA Treasurer presented 2020 report for approval. Report approved with none in opposition (attachment #5). Motion made to reimbursement Tim Hose \$50 for use of his personal Zoom account during Covid-19. Motion passed with none in opposition (attach #5).

Dumpster: Jena McDonnell secured dates for neighborhood dumpster (3/19; 4/16; 5/28; 7/2; 9/3). Dates will not be posted on Nextdoor due to security issues. Jena talked about the grant we were given for the sewer improvements (262K) we received 2 of the 3 years it was available

Dumpster will be delivered Nov 8th for neighborhood use. Be sure to mind the prohibited materials list.

New Projects 2019 - Ladder at beach swimming area was installed.

Anita Spence asked about the coyotes...they are still available for use to deter the geese. It was mentioned that we had tried several different ways to deter them, none of seem to have worked long term...cannot shoot them – so any ideas are welcome – noted that we can relocate eggs

Jena asked about the meet and greet we did this past year... to encourage an open line for neighbors to meet the POA Board and for the POA to hear their ideas or issues. She thought it was a mild success...that we did have a few show up that don't normally attend meetings...will try again next year

Jena presented the financial report prepared by Stacy Harter, Treasurer who was not able to attend. Question about the – 6K shown for 2020...Anita explained that we had found a lawyer that quoted us a lower price to combine the 5 BOAs. So it was a showing the savings from our last quote. This has not been voted on to do as of vet.

Jon Haslauer motioned to accept the financial report and Paul McDonnell seconded... Passed with majority vote

Jena presented to the group a list of items on the agenda for 2020. All passed. List attached. Jane Mages picked up ballots for record.
